

## Purchase Order Receivings Report—By Vendor Number

**Availability:** CompuPawn—Purchasing and Receivings with Product Module

**Inputs Used:** Determine selection parameters (*Shift, Date, Receipt number, etc.*)  
 • *Start Customer/Vendor / End Customer/Vendor = { Vendor number for a specific vendor }*

**Example:** This example shows a logical division of the Receivings Work File by vendor. This Purchase Order Receivings Report lists all items received from the specific vendor so that invoices from the vendor may be matched to this report. All items listed on this report are ready for transfer to inventory.
