

Firearm Log - Entire Gun Log Page

Availability: All CompuPawn configurations.

Inputs Used: Determine parameters (Shift, Gun Log No., etc.)

- *Start In Shift / End In Shift* = {Range}
- *Start Out Shift / End Out Shift* = {Same Range as above}
- *Print Selected Ones Only (Y/N)* = {N}

Example: This example shows a page of the gun log. Rather than reprinting the entire gun log, CompuPawn reprints only those pages affected by changes to the gun log due to acquisitions and/or dispositions of firearms [This is created automatically at the closing of a shift]. Use the newly revised pages of the gun log to replace the old pages and this will maintain a complete up-to-date printed gun log.
