

# Pawn Disposition Report

**Availability:** CompuPawn—General Reports  
CompuPawn-LITE—General Reports

**Inputs Used:** Determine date for reporting period  
 • *Start Date* = {Typically four (4) months prior to the date on which the report is being generated}  
 • *End Date* = {Last day of month listed in Start Date}

**Example:** This example shows a typical end-of-month Pawn Disposition Report that lists the disposition of all pawns that were processed in the month four months prior to the report run date. For example, at the end of May a Pawn Disposition report should be run for all pawn transaction processed in January so that the *Start Date* input should be 01/01/YY and the *End Date* input should be 01/31/YY
